Important terms of this agreement:

- *If a payment is more than 60 days late this pre-arrangement is cancelled and the monies forfeited.*
- *This contract may be cancelled with written notice, prior to services being rendered, and an 80% refund will be returned to the family within 30 days of cancellation – Please note that lack of payment does not constitute cancellation but is a forfeiture.*
- *The cost of this pre-arrangement is based on the weight of your pet. If your pet is under 2 years old at the time of this agreement, the price will be based on the average weight of the breed/breeds at maturity. If the pet weighs more or less of the value of this pre-need arrangement then there will be no change in value.*
- *I understand that Either I, as the pet owner/parent or my veterinarian's office is responsible for notifying Agee's Pet Crematorium upon our pet's death. – further, it is my responsibility as the pet parent to notify Agee's in the event of a change in my pet's veterinarian.*
- *It is also understood that unless a time is scheduled in advance of my pet's death, Agee's is open Monday-Friday, 9:30am until 5:00pm, accordingly that is when they are able to be contacted – in no way does this agreement imply 24 hours service –*
- *Agee's is not responsible for service if events beyond the company's control prevent performance, such events include but are not limited to: hurricanes, floods, or power outages.*
- *It is understood that there may be a limit to granting a "special request" such as lock of fur or paw print depending on the condition of the pet at the time of death.*
- *The prices on this form are guaranteed with respect to the cremation paid for with this form. There is a date at the bottom of each page to indicate the most current form available. The previous prices expire when this form is updated unless payment arrangements have been completed.*
